PUBLIC POLICY

AAUW will hold a Candidate Forum for the November election. Katrina Bartolomie, our County Clerk, released the list of positions that are up for election on November 8, 2022. Filing has begun and continues up to August 12. It is possible to extend the deadline if no incumbent files in a race. Up for election are three City Council seats, five Ukiah School Board seats and two Community College seats. We will need your help in gathering questions and keeping time. It will be at the Ukiah Civic Center at a date and time to be announced. There are also two local propositions—one to help fund the Library system and one to help-fund-the fire districts.

On the National AAUW Level

The American Association of University Women (AAUW) strongly condemns the U.S. Supreme Court's decision in Dobbs v. Jackson Women's Health Organization. The decision overturns the landmark Roe v. Wade ruling that established abortion as a constitutionally-protected right nearly 50 years ago and ignores the will of the American people, 80% of whom support legal abortion.

AAUW believes everyone has the right to make decisions about their own reproductive lives without government interference. Abortion access is vital to women's ability to control their lives, bodies and futures. Without reproductive freedom, there can be no equity. Being able to choose whether and when to become a parent improves women's well-being and fosters economic security—a crucial component of AAUW's mission. This is particularly important in a country that lacks accessible maternal health care, paid caregiving leave and workplace protections for pregnant workers.

The Court's decision hurts all of us, but it will do the most harm to low-income people, women of color, immigrants, people with disabilities and LGBTQ+ people, because these groups already face substantial barriers to accessing reproductive services and health care.

While the Court's decision is a major setback for all Americans, AAUW remains steadfast in our commitment to protecting reproductive rights, a vital component of gender equity.
